The European Association of Paritarian Institutions (AEIP) is pleased to announce that the 12th edition of the Transatlantic & World Pension Alliance Conference will take place in Crown Plaza Hotel Brussels on 27th-28th-29th May 2020.

The Conference is organized by AEIP in cooperation with the the <u>Multi-Employer Benefit Plan Council of Canada (MEBCO)</u>, National Coordinating Committee for Multiemployer <u>Plans (NCCMP)</u>, and the <u>World Pension Alliance</u>, currently chaired by the US <u>National Conference On Public Employee Retirement Systems (NCPERS)</u> for the day devoted to pensions.

Taking place on annual basis since 2008, the global Transatlantic & World Pension Alliance Conference traditionally focuses on global trends in healthcare, pensions and social dialogue in each of its 3 thematic days. In all panels of the Conference experts from the US, Canada and Europe will address the most relevant trends and policy tools from their perspective, providing the basis for a global exchange of experience and best practices.

This year, we have included the following topics as basis for an in-depth discussion with policy makers, industry and academia representatives:

On May 27, we will focus on global trends in healthcare and topics as: the future of healthcare in the context of an ageing society, access to healthcare and optimal coverage for citizens, raising cost of healthcare and price of medicine, digital transformation of healthcare, data management & data protection.

On May 28, in the day dedicated to **pensions**, we will discuss: global pension funds challenges (as low-interest rate environment, governance practices, shift DB & DC, solvency), ESG criteria in investment decisions of pension funds, expansion of coverage in occupational pensions, digitalization and new trends in communication in pensions.

In the morning of the last day of the Conference May 29, we will address the different policy approaches for effective engagement of social partners (trade unions and employer organizations) in collective bargaining / social dialogue, including a sectorial perspective on current labour market dynamics.

All topics of the Conference serve as a platform to exchange on the state-of-play of policy frameworks and legislation from a global perspective and their various social or economic impacts, drawing conclusions on best practices with potential for replication, ultimately providing policy recommendations.

The event brings together leading experts in pension and health benefits, as well as Trustees and plan professionals, policy makers and academia from Europe and North America to share their knowledge and expertise.
